The last date for uploading of online filled – in Examination Applications to the college principals concerned for registration with prescribed fee without fine is **08-02-2016**. 5	Uploading of online examination application with payment of fine (Rs.500/-): From 12-02-2016 to 14-02-2016.
6	Last date for fee remittance with fine (Rs.150/- + Rs.500/-) in the bank by principal with fine: 15-02-2016.
7	From 15-02-2016 onwards, candidates can register for the examination with provisional permission by the principal with a penal fee of Rs. 1500/- + Examination Fee.
8	Last date for submission of Nominal Rolls along with original challans and Covering Letter to the undersigned: 16-02-2016.

Hence, all the Principals are requested to bring this to the notice of all the concerned students and inform them to pay the examination fee on or before 08-02-2016. The examination applications of those candidates who have put up 75% attendance shall be forwarded to the undersigned for registration to the above said examination. Those who have not put up 75% but put up a minimum of 66% attendance have to pay the condonation fee as prescribed by the University.
